#### We are meeting with legislators across Virginia

Our chapters are meeting with legislators as we head into the General Assembly session in January. Members across the state have been able to share our legislative priorities, and have gained support for our priorities from some of our legislators.

Delegate Rasoul met with members of our Environmental Justice Strategy Committee and agreed to co-patron the bill with Delegate Seibold, who already agreed to patron the bill, to provide incarcerated folks with access to adequate cooling during extreme heat.

Other legislators agreed to support multiple issues, like Delegate Milde who will support our energy and utility, child care, healthcare, and some housing priorities. Senator Mulchi also expressed interest in working with our Halifax/South Boston Chapter on Restoration of Rights and child care.

Our Richmond Chapter and Environmental Justice Strategy Committee met with Delegate Carr this month, who has been a champion for many of our priorities. She has agreed to meet with our members in Richmond on Lobby Day in January.

Similarly, Speaker of the House Delegate Don Scott's legislative aide, Kathy Nguyen, met with statewide strategy committee members and Portsmouth Chapter members on his behalf and promised that Delegate Scott would meet with them in Richmond during the General Assembly session.

#### "Caroling for a Cause" in Newport News

On December 10, the Newport News/Hampton Chapter went "Caroling for a Cause" at the Newport News City Council meeting held at Christopher Newport University. Chapter members sang carols about the need for a shelter on the peninsula and called out city council to address this much-needed resource.

Viam Advising, a company hired by the city of Newport News to assess homelessness, spoke at a community meeting in November and stated that regional housing insecurity and homelessness will only increase over the next five years.

The chapter has urged both the Newport News and Hampton City Councils to invest in a regional shelter with wrap-around services that will act as a hand to help those in need. While the Hampton City Council has expressed support for the regional shelter, members of the Newport News City Council have been hesitant.

The peninsula region previously came together for animals and pets in need – to find them loving homes. Now, the chapter is calling on the Newport News City Council to do the same for their constituents in need.





# "The State of Child Care in Virginia" Zoom Meeting Recap

This week, we gathered on Zoom to talk about the current state of our Virginia child care system and what we can do as parents, child care providers, and community supporters to help make it better. The meeting was hosted by Virginia Organizing and Childcare Changemakers, and was attended by Virginia Organizing chapter members, Virginia Promise Partnership, and invited guests.

Topics of the meeting included the recent state budget wins for early childhood education, how the pandemic changed the outlook of child care funding, and what proposed changes by the incoming federal administration might mean for child care and our communities.

"The tax fight is a child care fight, and a healthcare fight, and an anti-hunger fight," said AnneRose Menachery of Childcare Changemakers.

Attendees were also given the opportunity to speak in groups about their experiences with the child care system, discuss the information that was shared to the group, and explore ideas for what the child care system should look like in the future.

During the meeting, speakers emphasized the importance of partnerships in this effort more now than ever.

"When we fight together, we absolutely win...we've seen a lot of power built when we realize that there are other people out there going through the same thing," said Virginia Organizing Executive Director, Brian Johns

## Richmond Chapter "Naughty or Nice" Forum for Rental Inspection Program



The Richmond Chapter of Virginia Organizing held a successful community forum with newly elected city council members to discuss the importance of a rental inspection program on Wednesday, December 4. Virginia Organizing received verbal commitments from city council members in attendance to prioritize the program.

One Richmond tenant who spoke at the forum emphasized the need for a rental inspection program, asserting that landlords "need to be held accountable." They discussed the hypocrisy of the current system, stating, "Communities are suffering... If you don't pay your rent, you get kicked out. But what happens to these [landlords] who have you living in uninhabitable properties and they are not held liable? Something needs to be done."

The lack of accountability has ultimately bred distrust amongst tenants. "We cannot trust our landlords or the city to stay accountable for the safety of our families," said another Richmond tenant, Kim Taylor.





Almost fifty Richmond tenants, community-based organizations, and local landlords attended the forum in favor of a rental inspection program.

Newly elected Richmond city council members Andrew "Gumby" Breton, of the 1st District, and Kenya Gibson, of the 3rd District, attended the forum and publicly committed to support the rental inspection program. Virginia State Senator Ghazala Hashmi also attended in support of the program.

While not in attendance at the event, the chapter received emails of support from council members Jordan, Lynch, and Jones. The chapter received no communication from the 6th, 7th, 8th council district teams about their support for the rental inspection program.

Richmond tenant and Virginia Organizing chapter leader, Melanie Taylor-Carden, summed up the issue with the statement, "our current code enforcement is the definition of putting a Band-Aid on the issue except we don't always have a Band-Aid big enough for a fallen roof."

As a follow-up to the community forum, Kim Taylor attended a Richmond city council meeting on Monday, December 9 to deliver "nice" certificates to council members who publicly committed to support the program and "naughty" certificates to those who have not. However, Taylor was cut off when sharing the "naughty" list, as the list was deemed to be "disparaging language."

Richmond tenants have waited long enough for landlords to be held accountable for uninhabitable living conditions. A rental inspection program must be prioritized now!
